



Qualifying Papers on Indian Languages and English :-

The aim of the paper is to test the candidate's ability to read and understand serious discursive prose, and to express his ideas clearly and correctly, in English and Indian language. The pattern of questions would be broadly as follows:

(i) Comprehension of given passages.
(ii) Precis Writing.
(iii) Usage and Vocabulary.
(iv) Short Essays. Indian Languages:-
(i) comprehension of given passages.
(ii) Precis Writing.
(iii) Usage and Vocabulary.
(iv) Short Essays.
(v) Translation from English to the Indian Language and vice-versa.

Note 1: The papers on Indian Languages and English will be of Matriculation or equivalent standard and will be of qualifying nature only. The marks obtained in these papers will not be counted for ranking.

Note 2: The candidates will have to answer the English and Indian Language papers in English and the respective Indian language (except where translation is involved).

Paper I

Essay :-

Candidates may be required to write essays on multiple topics. They will be expected to keep close to the subject of the essay to arrange their ideas in an orderly fashion and to write concisely. Credit will be given for effective and exact expression.

Paper II

General Studies I:

Indian Heritage and Culture, History and Geography of the World and the Society

- Indian culture will cover the salient aspects of Art Forms, literature and Architecture from ancient to modern times.
- Modern Indian history from about the middle of the eighteenth century until the present significant events, personalities, issues.
- The Freedom Struggle its various stages and important contributors/contributions from different parts of the country.
- Post-independence consolidation and reorganisation within the country.
- History of the world will include events from the 18th century such as industrial revolution, world wars, redrawal of national boundaries, colonisation, decolonization, political philosophies like communism, capitalism, socialism etc.— their forms and effect on the society.
- Salient features of Indian Society, Diversity of India.
- Role of women and women's organisation, population and associated issues, poverty and developmental issues, urbanisation, their problems and their remedies.
- Effects of globalisation on Indian society.
- Social empowerment, communalism, regionalism & secularism.
- Salient features of the world's physical geography.
- Distribution of key natural resources across the world (including South Asia and the Indian sub-continent); factors responsible for the location of primary, secondary, and tertiary sector industries in various parts of the world (including India).

• Important Geophysical phenomena such as earthquakes, Tsunami, Volcanic activity, cyclones. etc., geographical features and their location-changes in critical geographical features (including water-bodies and ice-caps) and in flora and fauna and the effects of such changes.

Governance, Constitution, Polity, Social Justice, and International Relations

• Constitution of India —historical underpinnings, evolution, features, amendments, significant provisions and basic structure.

• Functions and responsibilities of the Union and the States, issues and challenges pertaining to the federal structure, devolution of powers and finances up to local levels and challenges therein.

- Separation of powers between various organs dispute redressal mechanisms and institutions.
- Comparison of the Indian constitutional scheme with that of other countries.
- Parliament and State legislatures—structure, functioning, conduct of business, powers & privileges and issues arising out of these.



UPSC CSAT Syllabus Trend Analysis (2011-2023)


